For Students and Parents

Contract of Attendance

- No unexcused absences will be tolerated.
- If you hope to obtain an excused absence, official absence request is required at least 48 hours prior to the day that will be missed.
- Official absence requests must be submitted in written form via letter or email to the Instructor of your specific program.
- It is required that you arrive on time (or join the Zoom meeting on time) for each program. On time is at least 5 minutes prior to the start of the event.
- An unexcused tardy will be counted as an unexcused absence.
- Excused tardy requests must be submitted in the same way as excused absences (see above).

Tutoring Sessions Agreement

- Provide undivided attention to all speakers at all times.
- Maintain your space clean and clean up after yourself after every session.
- Be open to working with others providing and receiving feedback from peers.
- Follow conduct rules in the Student Manual.
- School dress code applies.
- Submit completed assignments on time.
- Failure to submit assignments on-time or completely at the Instructors request will result in removal from the program.

Conduct During Activity
